Subject: 2019 Metrobank-MTAP-DepEd Math Challenge Division Elimination Round

Date: January 3, 2019

1. The Metrobank Foundation, Inc. (MBFI), the Mathematics Teachers Association of the Philippines (MTAP) and the Department of Education (DepEd) announces its annual Mathematics competition for elementary and junior high school students in both public and private schools nationwide. This will be administered on January 17, 2019 (Elementary) and January 18, 2019 (Secondary) at Cogon National High School, Cogon, El Salvador City, Misamis Oriental. The competition will start at exactly 8:00 o'clock in the morning.
2. The overall objectives of the Metrobank-MTAP-DepEd Math Challenge is to contribute in improving the quality of mathematics education in the Philippines. Specifically, it aims to:
 - A. Awaken greater interest in mathematics among elementary and secondary students in both public and private schools all over the country;
 - B. Encourage students to strive for excellence in Mathematics;
 - C. Discover mathematical talents among the students;
 - D. Develop the values of hard work, perseverance, honesty, teamwork and sportsmanship, and
 - E. Provide learners with opportunities in leadership and cooperative undertaking.
3. The coverage of the competition shall be strictly the current and approved DepEd K to 12 Education Curriculum for Elementary and Junior High School, per grade level.
4. Only grades 6 and 10 qualifiers in both individual and team categories can participate the regional and national levels.
5. Working committee/officials are expected to perform their respective role in the conduct of the elimination round. Arrangements for substitute officials must be facilitated earlier to ensure that classes of the participating teachers/coaches/officials will not be disrupted.
6. Participants are expected to report to the venue at exactly 7:00 a.m.
7. Hereto attached is the list of Working Committee and Officials.
8. Meals/snacks of working officials and materials incurred in the activity shall be charged against Division MOOE, while transportation, meals/snacks of the participants and coaches shall be charged against local funds/MOOE/PTA subject to usual accounting and auditing procedures/policies, rules and regulations.
9. Immediate dissemination of this memorandum to all concerned is earnestly desired.
