- 1. With reference to Regional Memorandum 136, s. 2020, all are reminded of the following precautionary measures to contain the spread of Corona Virus Disease 2019 (COVID-19):
  - i. Mandatory self-quarantine for 14 days shall not be charged to the leave credits of the personnel
  - ii. Alternative delivery mode (ADM) of education shall be provided for the learners
  - iii. Suspension of national, regional and/or off-campus activities, scheduled on March 2020, must be strictly observed. Should the activities push through, the organizers shall seek the approval and recommendation of the local health authorities
  - iv. Schools must diligently implement the Preventive Alert System and ensure that there is adequate supply of water, soap, hand sanitizers and alcohol. Maintenance of cleanliness must remain a priority in all schools.
  - v. Weekly Health Situation Reports must be submitted by SDO c/o Health Section

FULL IMPLEMENTATION OF THE FIFTH SET OF POLICY DIRECTIVES OF THE DEPED TASK FORCE COVID-2019 (DM 034, S 2020)

To: Schools Division Superintendents

This Region

- 1. As a response to DM 034, s. 2020 on the developments to contain the spread of Corona Virus Disease 19 (COVID-2019), the Department of Education (DepEd) Region X fully implements the appropriate changes in the measures for prevention and control of this virus in all offices and schools in the respective divisions while all other provisions of DM 015, s. 2020 titled First Set of Policy Directives of the DepEd Task Force NCOV and the series of updates thereafter remain.
- 2. This Office directs all Schools Division Offices (SDOs) to reiterate and elaborate the travel measures and restrictions in the Enclosure No. 2 of DM 015, s. 2020 while giving emphasis to the mandatory self-quarantine for 14 days from the date of arrival of travelers from countries listed in the table provided in DM 034, s 2020, which shall no longer be charged to the leave credits of the personnel, while for the learners shall be provided alternative delivery mode (ADM) of education.
- 3. Suspension of March 2020 conduct of all national, regional, and/or off-campus activities must be observed strictly and should the activities push through in the districts and divisions, the organizers shall seek the approval and recommendation of the local health authorities. Preventive Alert System in Schools must be diligently implemented and Weekly Health Situation Reports must be submitted by SDOs while adequate supply of water, soap, hand sanitizers, alcohol, and maintenance of cleanliness must remain a priority in all public schools. Private schools are highly encouraged in the interest of public health to adopt the same precautionary measures.
- 4. Immediate and wide dissemination of this Memorandum is desired.
