

The Department of Education (DepEd) Region X Information Communications Technology Unit (ICTU), in coordination with the Department of Information and Communications Technology (DICT), is mandated to plan, develop, and promote the national ICT development agenda. One of the main thrusts is to provide an inclusive and thriving ICT environment focused on developing the countryside.
2. One of the projects under countryside development is Technology Empowerment for Education, Employment, Entrepreneurship, and Economic Development (Tech4ED), which is aimed at providing and developing innovative ICT-enabled services and content for the socio-economic development of communities.
