1. The Department of Education (DepEd), through the Bureau of Learning Delivery Teaching and Learning Division (BLD-TLD), will conduct an **Online National Training for Kindergarten Remote Teaching and Learning: Developmentally Appropriate Responses in the Time of COVID-19** on September 21-25 for Mindanao cluster.
2. The participants are Education Program Supervisors (EPS) from the Regional Office (RO) and Schools Division Offices (SDOs), all elementary school heads/principals, and all kindergarten teachers.
