BAC RESOLUTION

WHEREAS, the Department of Education, Division of El Salvador City advertised the Invitation to Apply for Eligibility and to Bid for the *Procurement and Delivery of Materials for the Reproduction of Modules (PB No. 2020-08-0053)* and posted the same in the PhilGEPS;

WHEREAS, in response to the said advertisements, one (1) bidder submitted bid during the opening;

WHEREAS, during the opening of Bids on September 2, 2020, lone bidder passed in the preliminary evaluation of bids, R and K General Merchandise;

WHEREAS, upon detailed bid evaluation of the submitted bid documents of R and K General Merchandise, the following notable findings were observed by the technical working group, such as but not limited to:

- a.) Absence of tax clearance;
- b.) Lacking statement of all its on-going government & private contract;
- c.) Lacking statement of bidders SLCC;
- d.) Bid securing declaration is invalid and expired (handwritten, erasures were not countersigned, and date of notary is June 22, 2020) which is prior to the date of this current project;
- e.) Omnibus sworn statement is premature since it does not coincide with the procurement of this current project which is August 2020;
- f.) Bid form is not appropriately addressed to the procuring entity and that no bid price is offered therein.

WHEREAS, section 35.1 of the revised 2016 IRR states that *“the BAC shall declare the bidding a failure when: a) no bids received; b) all prospective bidders are declared ineligible; c) All bids fail to comply with all the bid requirements or fail post-qualification, or, in the case of consulting services, there is no successful negotiation;”*

WHEREAS, the Bids and Awards Committee had unanimously decided based on the above-cited grounds stated therein that the submitted bid of R and K General Merchandise has been disqualified.

NOW, THEREFORE, We, the members of the BAC, hereby RESOLVE as it is RESOLVED to declare failure of bidding of the ***Procurement and Delivery of Materials for the Reproduction of Modules (PB No. 2020-08-0053)*** in the sum of *One Million Two Hundred Forty-Seven Thousand and Five Hundred Pesos only (Php 1,247,500.00)*.




