DIVISION MEMORANDUM No. 076, s. 2020

PREPARATION FOR QUARTERS 3 AND 4 SELF LEARNING MODULES

To: Division Education Supervisors
Elementary and Secondary School Heads
All Others Concerned

- 1. Pursuant to the Regional Memorandum No. 68, s. 2021, several changes have been made for this School year's implementation of distance learning delivery mode, as classes gearing toward the end of Quarter 2 and the beginning of Quarter.
- 2. DepEd Central Office (CO) will procure the Self Learning Modules for Quarter 3 and Quarter 4 for **Grades 4-10**, **except SLMs on EPP/TLE**. The procured modules will be delivered in March 2021. The modules will be on 1:3 ratio in the distribution of SLMs.
- 3. However, with reference to the result of the conformance review of the submitted SLMs from the publisher, the following subjects failed in the evaluation of the reviewers: Grade 4 (Arts), Grade 5 (PE), Grade 6 (PE), Grade 7 (AP, ESP, Music, PE), Grade 8 AP, Grade 9 (Music, Arts). As per information from the Bureau of Learning Resources, these SLMs together with the EPP/TLE and SHS (core and applied subjects), will be reproduced by the SDOs, and the CO will download the funds for the reproduction of the SLMs for the said learning areas.
- Target date of distribution by the CO to the Regional Office (RO) is 3rd week of March. A separate memorandum on the distribution of the CO-produced SLMs will be released soon
- Please be reminded also that the printing for Kindergarten to Grade 3 will be done by SDOs from the downloaded funds from the Region.

6. Furthermore, please be guided by the OUCI and OUF Memo DM OUCI:2020-358 (Supplementary Guidelines in the utilization of Downloaded Funds for Provision of Learning resources), which emphasize the Ros/SDOs may utilized the funds downloaded to either:

a. Fund printing and delivery of modules; or

- Fund the procurement of gadgets in accordance with the specifications provided by ICTS and which should not exceed Php 15,000.00/gadget.
- 7. On the other hand, in case there are delays in the distribution, which maybe due to health protocols and other unforeseen circumstances, the field is encouraged to reproduce the Self Learning Modules/Learning Activity Sheets of the first three weeks of Quarter 3 to ensure continuity of the delivery of the teaching learning process. Funds for the reproduction of the 1st three weeks of Q3 can be sourced out from the MOOE/SEF and other sources of funds, subject to usual auditing rules and regulations.
- 8. This Office shall adhere to Equal Opportunity Principle (EOP) in receiving the general plan of activities and attending to clarification/queries relative to Preparation for Quarters 3 and Self Learning Modules. Hence, all decisions and actions shall be based on guidelines set forth, with no discrimination on the account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity or political affiliation.
