**ADHERENCE TO THE FULL IMPLEMENTATION OF
DTFC MEMORANDUM NO. 372, GUIDANCE ON COVID-19 VACCINATION
FOR DEPED TEACHING AND NON-TEACHING PERSONNEL**

1. To reduce morbidity and mortality caused by Coronavirus infection, this Office adheres to the DepEd Task Force COVID-19 (DTFC) issuance Memorandum No. 372 issued on April 19, 2021 and to RM No. 177, s. 2021 re: Full Implementation Of Guidance On COVID-19 Vaccination For DepEd Teaching and Non-teaching, DFTC Memorandum No. 372.
2. Furthermore, this office supports and advocates for the complete COVID-19 vaccination of the DepEd teaching and non-teaching personnel recognizing it as one of the major strategies to complement with the existing measures and practices to combat coronavirus infection with emphasis on the three levels of participation of DepEd on the National Deployment and Vaccination Plan (NDVP):
 - a. as vaccine recipients or beneficiaries
 - b. as member of the vaccination task group or teams
 - c. as champions for advocacy on vaccination
3. Moreover, this Office reiterates that consistent with the IATF Resolution No. 110 s. 2021, the category of all basic education frontliners has been adjusted **from B1 to now being part of the Priority Group A4**. Therefore, the DepEd frontline teaching and non-teaching personnel may register for vaccination under A4

4. The Deped personnel are directed to continue with the strict observance to the required health standards before, during and after vaccination.

Hence, all decisions and actions shall be based solely on guidelines set forth, with no discrimination on the account of age, gender identity, sexual orientation, civil status, disability, religion, ethnicity or political affiliation
