    - iii. Autobiography

- iv. Entries/Evidences with Caption, Purpose and Reflection
  - Artefacts activity sheets, essays, poems, project paper
  - Reproduction pictures, CDs, any proofs of performances
  - Attestation certificates, notes,
- v. Reflective Summary
  - a critique of the entire body of work in the portfolio
  - may be placed at the end or at the beginning of the portfolio or section of the portfolio, as applicable.
  - shows new learnings such as the ability to critically assess, transfer, integrate, or apply knowledge.
  - traces how the developer has captured and portrayed growth, competencies, and context.
- 2. The submission of the reports shall be sent to Google drive at bit.ly/ELSAassessment on or before May 10.
- 3. This Office shall adhere to Equal Opportunity Principle (EOP). Hence, all decisions and actions shall be based on guidelines set forth, with no discrimination on the account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity or political affiliation.
