DepEd Order 39, s. 2016 (Adoption of the Basic Education Research Agenda) highlights the significant contribution of research to fully establish policies and implement goals directed towards the learners; thus, effectively instigating the Department of Education's mandate consistent with its vision. With this, the Office announces the call for basic/action research with its imperative to highlight significant findings, timely recommendations and salient points in the study that will help address challenges in the schools and functional units in the SDO.
2. Hard copy of the research summaries with all the attachments (*please see annexes*) shall be submitted on or before **August 20, 2021** through RIZAN L. SARDANE. Meanwhile, soft copy of the **full research manuscripts** shall be forwarded to karenrose.serrania@deped.gov.ph using the official school email.

3. The school heads together with their assigned Technical Assistance Providers (TAP) are directed to oversee and ensure completeness and correctness of documents needed before submission.
4. Attached is the template of the Research Summaries and its components for reference. These research summaries are to be extracted from the research studies conducted. The research summary of each personnel should appear in **one (1) page only** containing the parts specified in the template.
5. Further, the foregoing activity shall abide with the guidelines stipulated in DepEd Order No.16 series 2017, Re: Research Management Guidelines and other appropriate guidelines. A **maximum of 3 proponents** in a research shall be strictly observed.
6. Please take note of the following:
 - a. Prepare the printed documents in two (2) sets. One set for the Provincial Accounting Office and the other one for the Commission on Audit (COA-Province). Every folder shall contain the Journal Entry Voucher (JEV) in four (4) copies, Obligation Request (ObR) in four (4) copies and the General Payroll in three (3) copies.
 - b. The compilation of the attachments shall start with research summary of the study undertaken by the School Head followed by the research summaries of the teaching, teaching-related and non-teaching personnel of the school (in alphabetical order regardless of the position). Tabbing should be observed strictly to facilitate a fast checking and evaluation against the General Payroll.
 - c. Teaching, teaching-related and non-teaching personnel hired from January 1, 2021 up to the present are required to submit a photocopy of the appointment signed by the Schools Division Superintendent. These photocopied documents should be attached to the General Payroll for reference.
