1. With reference to DepEd Memorandum No. 048, s. 2021 **Re: 2021 Brigada Eskwela Implementing Guidelines** particularly item no.9, which stipulates that Teaching personnel are entitled to earn vacation service credits arising from their active involvement as member of the School Brigada Eskwela working committees and/ or voluntary services in the Brigada Eskwela activities , this Office, informs the filed that all teachers who will render services during the implementation of 2021 Brigada Eskwela from August 3 to September 30, 2021 shall earn a one (1) day service credits for accumulated eight (8) hours as committee member or volunteer in school preparation and partnership activities but not to exceed the total ten (10) days of service credits.
2. Teachers who will request service credits shall comply with the provisions stated hereunder:
 - a. Attached two copies of Daily Time Record (DTR) duly signed by the School Head.
 - b. Attendance sheets during the conduct of the activity.
