**UPDATES AND REMINDERS ON THE BASIC EDUCATION  
LEARNING CONTINUITY PLAN IMPLEMENTATION  
FOR SY 2021 - 2022**

1. To ensure an effective and efficient implementation of the Basic Education Learning Continuity Plan for SY 2021-2022, schools shall adhere to the mandates and strategies as stipulated on the issuances from the offices of central, regional and divisional.

2. The following updates and reminders are as follows:

a. Pursuant to **DepEd Order No. 29, s. 2021 on the School Calendar and Activities for SY 2021-2022**, to wit:

4. The conduct of face-to-face classes, whether in partial full scale, will not be allowed unless permitted by the Office of the President.

Item V, 12 of the Implementing Guidelines on the School Calendar and Activities for School Year 2021-2022 states that *“The Basic Education Learning Continuity Plan (BE-LCP), as contained in DepEd Order No. 012, s. 2020 entitled “Adoption of the Basic Education Learning Continuity Plan for School Year 2020-2021 in the Light of the COVID-19 Public Health Emergency” shall continue to provide guidance on the delivery of basic education for SY 2021-2022.”*

Item V, 14 of the Implementing Guidelines on the School Calendar and Activities for School Year 2021-2022 states that the “Assessment of Learning shall follow DO No. 031, s. 2020 entitled Interim Guidelines for Assessment in Light of the Basic Education Learning Continuity Plan.

- b. Regular encoding of grades in the Curriculum Management Support System through <http://27.110.168.75/rox-cms/> based on the **Regional Memorandum No. 101, s. 2021 on the Implementation of Curriculum Management System in Light of the Basic Education**
- c. Performance tasks and portfolio assessment shall be thematic across learning areas by grade level. Relative to this, schools are required to submit the following on or before October 8.
- i. LAC Implementation Plan
  - ii. Curriculum Map on Thematic Performance Task for Quarter
  - iii. Curriculum Map on Thematic Portfolio Assessment
  - iv. Monitoring Plan
- d. All schools are required to accomplish the electronic monitoring tool provided in the google drive titled Monitoring of the BE LCP for SY 2021-2022.
