



CONTRACT AGREEMENT
Contract No. 2021-09-0182

THIS AGREEMENT made the **24th** day of **September 2021** between the Department of Education, Division of El Salvador City, located at Zone 3, Poblacion, El Salvador City, represented herein by its Schools Division Superintendent, **OLGA C. ALONSABE, Ph.D., CESE**, hereinafter referred to as the “Entity” of the one part and **DATAWORLD COMPUTER CENTER**, represented herein by its Owner/Proprietor, **BENJAMIN G. CHAN, JR.** with office address at Tirso Neri St., Barangay 08, Cagayan De Oro City, hereinafter referred to as the “Supplier” of the other part;

WHEREAS, the Entity invited bids for certain goods and ancillary services, particularly the **Procurement of Supply, Delivery, Installation, Testing and Commissioning of Data Network Cabling (Structured Cabling System) of the Division of El Salvador City with Project Number 2021-07-0106** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of *Nine Hundred Ninety-Nine Thousand Eight Hundred Pesos only (Php.999,800.00)* with a contract duration of One Hundred Twenty (120) calendar days; starting the receipt of Notice To Proceed (NTP hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder bid, including the eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning**
