## **RESOLUTION TO AWARD**

WHEREAS, the Department of Education, Division of El Salvador City advertised the Invitation to Apply for Eligibility and to Bid for the **Procurement of Repair** and **Rehabilitation of School Buildings at Kibonbon Elementary School** with **Project No. 2021-07-0099** and posted the same in the PhilGEPS;

WHEREAS, in response to the said advertisement/s, four (4) bidders submitted bid during the opening;

WHEREAS, during the opening of bids on August 18, 2021, four (4) bidders passed in the preliminary evaluation of bids with *JOASH AR ENGINEERING ENTERPRISES* as the lowest calculated bid as read below;

WHEREAS, after detailed bid evaluation, JOASH AR ENGINEERING ENTERPRISES has been disqualified due to various discrepancies such as noninclusion of receipts as proofs of ownership for the list of minimum required equipment, the submitted bid form item "G" did not declare amount for the Performance Security and item "K" the name of the project and Procuring Entity were not indicated and in detailed estimates the bidder have failed to incorporate the summary sheet indicating the equipment rentals used in coming up with the bid;

WHEREAS, *GREEN BUILDERS & ENTERPRISES*, the submitted bid indicate "No On-going Project" for Government and "None for Private" in the Statement of All On-going Government and Private Contracts including contracts awarded but not yet started. However, upon checking the list of All On-going Projects in DepEd, Regional Office – X, it was found out that *Green Builders & Enterprises* is currently under contract with the Department of Education, Division of Bukidnon with Project Name "CY 2020 BEFF Repair of Classrooms Batch 3; Lot No. 2 Repair of 7 Classrooms at Barorawon ES, Kalilangan with Contract No. 17-2020. In Detailed Cost Estimates, particularly item no. 6.000 under Doors and Windows the procuring entity (PE) requires for Jalousie Window with Clear Glass Blades on JalouPlus Type Silver Colored Frame with Grilles. However, in the bidders submitted detailed cost estimates Grilles was omitted. Therefore, the bid was insufficient, did not conform to the required item which is a ground for disqualification. Hence, the bid has been disqualified based on the above-cited grounds;

WHEREAS, *JDE CONSTRUCTION*, in the Statement of All On-going Government and Private Contracts including Contracts Awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, the document submitted indicate only a project from the Department of Health with project name Construction of Proposed Temporary Treatment and Monitoring Facility, Province of Misamis Oriental. However, upon checking the list of All On-going Projects in DepEd, Regional Office – X database, it was found out that JDE CONSTRUCTION is currently under contract with the Department

of Education, Regional Office - X with Project Name "CONSERVATION AND RESTORATION OF GABALDON BUILDINGS (GABALDON2020) - LOT 2 (Mambajao CES) and LOT 3 (Mambajao CES - HE)" and that such failure to declare is contrary to the existing rules on procurement law as stipulated in the Government Procurement Policy Board (GPPB) NPM No. 111-2013;

WHEREAS, after series of rigorous bid evaluation and post qualification of *JIMWEN CONSTRUCTION AND GENERAL MERCHANDISE* on October 5, 2021 or careful examination, validation and verification of all eligibility, technical and financial requirements submitted to the BAC, the said bidder passed the Post Qualification Evaluation as the Lowest Calculated and Responsive Bid, and therefore, considered for award of the contract;

NOW, THEREFORE, We, the members of the BAC, hereby RESOLVE as it is RESOLVED to recommend the award of contract to JIMWEN CONSTRUCTION AND GENERAL MERCHANDISE for the **Procurement of Repair and Rehabilitation of School Buildings at Kibonbon Elementary School with Project No. 2021-07-0099** in the sum of **Two Million Seven Hundred Nine Thousand Five Hundred Pesos and Forty-Five centavos** only (**Php**, **2,709,500.45**).
