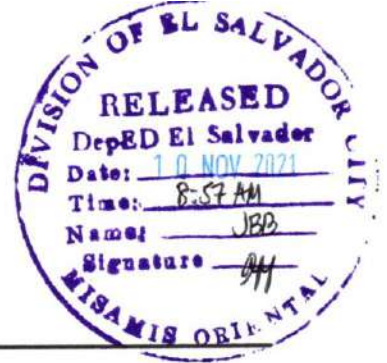

1. This issuance is with reference to **DepEd Order (DO) No. 31, s. 2018**, titled the Policy Implementation Guidelines of the Comprehensive Sexuality Education, which is aimed at establishing a common understanding of the CSE key concepts and messages and ensuring clear implementation of protocols in the CSE and Regional Memorandum no. 470, s.2021, Training and Capacity Building on Integrating the Comprehensive Sexuality Education in Teaching.
2. The Division of El Salvador City, in cooperation with the Population Commission (PopCom) of El Salvador City, will conduct a virtual training and capacity building for school heads and teachers on integrating the Comprehensive Sexuality Education in Teaching on **November 16-17, 2021**.
3. The purposes of this activity are the following:
 - a. Capacitate the teachers on how to integrate the key concepts and messages of CSE in the lesson.
 - b. Explore the entry point of the CSE key concepts and messages to the K-12 Curriculum; and,
 - c. Capacitate the school heads about the LAC CSE modules for proper provision of technical assistance.
4. The participants of this activity are the school heads, school CSE coordinators and identified teachers of Kindergarten, Araling Panlipunan, Science, Edukasyon sa Pagpapakatao, MAPEH and Personality Development. Please see attachment No. 1.
