



CONTRACT AGREEMENT

THIS AGREEMENT made this **7th** day of **December 2021** by and between the Department of Education, Division of El Salvador City, with principal office address located at Zone 3, Poblacion, El Salvador City, Misamis Oriental and represented herein by its Schools Division Superintendent, **OLGA C. ALONSABE, Ph.D., CESE**, hereinafter referred to as the **"ENTITY"** of the one part

and

BESTFRIEND GOODIES, duly represented herein by its Chief Operating Officer, **MS. NENITA M. TAN** with office address at B9 Lot 51-57 Primerose St. Camella Homes, Upper Balulang, Cagayan De Oro City, hereinafter referred to as the **"SUPPLIER"** of the other part;

WHEREAS, the Entity invited bids for certain goods and ancillary services, particularly the **Procurement of Enhanced Nutribun for the Conduct of School-Based Feeding Program with Project Number 2021-10-0145**) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Six Hundred Sixty-Two Thousand One Hundred Twenty Pesos only (Php.1,662,120.00)** with a contract duration of **sixty (60) school days**; starting from the receipt of Notice To Proceed (NTP hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:

Bid form, including all the documents statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **One Million Six Hundred Sixty-Two Thousand One Hundred Twenty Pesos Only (Php. 1,662,120.00)**, **NENITA M. TAN/ Bestfriend Goodies** agrees to in accordance with his/her/its Bid.
4. The Department of Education, Division of El Salvador City agrees partial payment of the staggered delivered goods (the NUTRIBUN) and that such partial payment must correspond and equitable to the value of the goods actually delivered and accepted (usually every after the fourth delivery of the said month which may fall within the 20th school days).

Payment must only be made after the Supplier's strict compliance with the appropriate inspection and acceptance procedure enforced by the procuring entity's inspectorate team, as mandated by the prevailing government rules and regulations.
