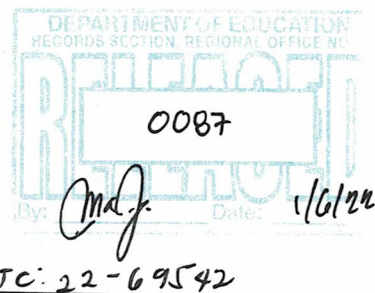

- All entries must be in digital format using Adobe Photoshop and/or Adobe Illustrator (editable .psd file with 300 dpi/resolution) with the following attachments:
 - Printed copy in A4 size
 - Rationale of the logo and its components (not more than 500 words, Arial 11, 1.5 spacing, justified)
- The design of the logo should be in accordance with the RDC-X RGADC framework. It should communicate a proactive, progressive, and empowered Committee to implement GAD-related plans, policies, programs, projects, and activities.
- The participants declare that the submitted entry is their original work, have not been submitted to any other competition, and does not infringe on any third party's existing copyright. Any complaint that may arise due to similarities, likeness or comparison of the design would be the accountability and responsibility of the participant to prove its authenticity.
- All participants will each receive a Certificate of Recognition.
- One chosen winner shall receive PHP5,000 cash prize and will be informed through an official letter from the RGADC. The awarding will be during the 1st quarter 2022 RDC-X RGADC meeting.
- It is understood that the winning logo shall become a property of the RDC-X RGADC. The logo can be published in its website, and in other media and corporate materials, such as letterheads and envelopes. The RGADC reserves the right to further refine or make improvements and alterations on the final design of the winning entry.
