**SELF-REPORTING COVID MONITORING APPLICATION GUIDELINES
FOR UPDATING AND RESUBMISSION OF VACCINATION STATUS**

To: **All Teaching and Non-Teaching Personnel**
All Others Concerned
This Division

1. It is hereby directed that all teaching and non-teaching personnel should access the DepEd Mobile App to update the status of their vaccination.
2. It is important that each personnel should be logged in to their DepEd Email account or O365 account when submitting the status of vaccination.
3. It is also requested that the School Head and Schools ICT Coordinator will ensure that each personnel in their school will be able to update the status of their vaccination through the DepEd Mobile App.
4. The deadline to accomplish this is on or before January 17, 2022.
5. See attached RM No. 16, s. 2022 for more details on how to download and access the DepEd Mobile App.

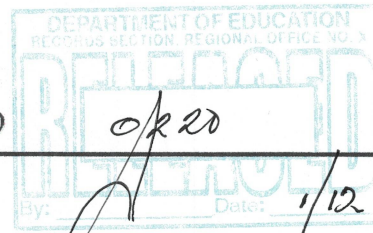

1. About **OUA MEMORANDUM 00-0122-0029** dated January 7, 2022, all concerned COVID-19 focal persons, with the assistance of their Information Technology Officers (ITOs), shall coordinate with all their DepEd personnel to resend their vaccination statuses via the DepEd Monitoring Application. It is important especially for those DepEd employees who used other personnel's mobile gadget and submitted their vaccine statuses using only one DepEd email account to ensure that their responses are recorded in the vaccination reports.
2. Attached is the **OUA MEMORANDUM 00-0122-0029** for reference on all the necessary steps to be accomplished.
3. Those employees in the Regional Office (RO) and Schools Division Offices (SDOs) who have not installed the DepEd Mobile App in their mobile device, **please download the installer via mobileapp.deped.gov.ph or download the app via Google Play Store for android devices or DepEd Mobile app via App Store for iOS.**

**Subject: GUIDELINES FOR THE UPDATING AND RESUBMISSION OF
VACCINATION STATUS THROUGH THE SELF-REPORTING
COVID MONITORING APPLICATION**

The Office of the Undersecretary for Administration (OUA), through the Bureau of Learner Support Services-School Health Division (BLSS-SHD) and the Information and Communications Technology Service (ICTS) with its implementing partner Intelimina Systems, Inc., issues the Guidelines on the Updating of Vaccination Status of Department of Education Personnel through the Self-Reporting COVID Monitoring Application.

All concerned COVID-19 Focals, with assistance of their respective Information Technology Officers (ITOs) shall coordinate with DepEd personnel under their jurisdiction to re-send their vaccination status via the DepEd Monitoring Application. This is particularly important for those DepEd employees or personnel who used other people's mobile gadgets/cellphones to submit their data.

An audit of the data submitted through the DepEd Monitoring Application has revealed groups of personnel that submitted their vaccine status using only one DepEd email account. In such case, only the last response sent through has been recorded in the vaccination reports.

While the monitoring application allows one gadget to be used by many respondents, it is however required and necessary that each user must first log-out from the application and the device before the next user will use the application, logging in with his/her own username/password or DepEd email address.

In this regard, kindly take note of the following and ensure all necessary steps are accomplished:

I. For COVID-19 Focals: Updating of Vaccinees

1. COVID-19 Focal Persons will be sent a spreadsheet containing responses from the DepEd Monitoring Application from the respective divisions where different names appear under one DepEd Account. If the spreadsheet is not received, data under the division is correct.
2. Each person listed in the spreadsheet must be contacted to accomplish the procedures under Re-submitting Your Vaccination Status. **Only the persons listed in the spreadsheet will be required to re-submit their data.**

II. For Concerned DepEd Personnel: Re-submitting of Vaccination Status

Ensure that the DepEd Mobile App is installed in your device. If the DepEd Mobile App is not installed in your mobile device, find and download the installer at mobileapp.deped.gov.ph or [Download app on Google Play Store](#) for android devices. For iOS, [download DepEd Mobile app on App Store](#).

1. On your mobile device, open the DepEd Mobile application.



3. Log-in via DepEd Commons. **Make sure that you are logged in to your account, not another person's account.**

Note: If you already have an account in DepEd Commons, you may use it to log in to the DepEd Mobile app.

4. On the login page of the DepEd Mobile app, click "**Sign in with DepEd Commons**". You will be redirected to the login page of DepEd Commons for teachers.

5. You have three ways to login. You may choose one preferred method:

5.1. **Option 1 - Enter DepEd Commons** activated login credentials on the form. (You must have an activated DepEd Commons account after confirming your Office 365 email address).

Coordinate with respective ITO for the creation of Office 365 Account. Refer to DepEd Memorandum No. 227, s. 2012 for the creation of DepEd Accounts.

- 5.2. **Option 2 - Sign in with Google (GSuite, DepEd Gmail)**

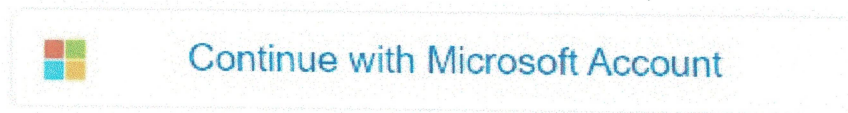

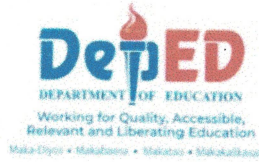



- Click on **Surveys/Trackers** and select **Self-Reporting for COVID-19 Vaccination**. Answer the questionnaire and review your responses before submitting.

Kindly note that each response **must be submitted using the user's own DepEd Account** so that they can be properly consolidated. To enforce this, the DepEd Monitoring Application **automatically logs out a user immediately after a response is submitted**. This feature ensures that users will log in to their accounts before answering a survey even if they are sharing a single device.

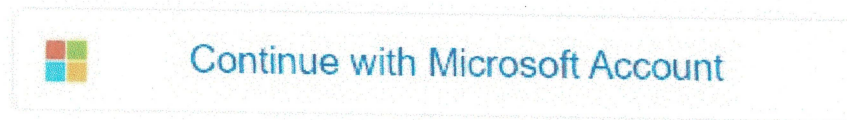
