#### ADMINISTRATIVE NOTE

#### 1. PURPOSE

The Office of the Undersecretary for Legislative Affairs, External Partnerships, Project Management Service and Private Education Office (OULAPPP) through the Project Management Service (PMS), and the Office of the Undersecretary for Field Operations (OUFO) have worked together to revise and update the existing policies governing the Parent-Teacher Associations (PTAs). The approved DepEd Order (DO) No. 13, s. 2022 titled "Omnibus Guidelines on the Regulation of Operations of Parent-Teacher Associations" is the result of the collaboration of the said strands.

With the approval of DO No. 13, s. 2022, the External Partnerships Service (EPS) in coordination with the PMS shall conduct the National Parent-Teacher Associations (PTA) Forum on DepEd Order No. 13, s. 2022 titled "Omnibus Guidelines on the Regulation of Operations of Parent-Teacher Associations in Clustered Regions.
