

In reference to OULAPPP Memorandum No. Q-266, s. 2022, titled **Project W.A.T.C.H. 3rd Summit (We Advocate Time Consciousness and Honesty)** dated July 5, 2022, the Junior Chamber International (JCI) Senate Philippines and the Department of Education (DepEd), through the External Partnerships Service (EPS) shall conduct the **Project W.A.T.C.H. 3rd Summit** with the theme: WE A.R.E. (Adapt, Response, Expand) Project W.A.T.C.H. on **August 3 to 5, 2022** at Baguio Teachers' Camp (BTC) in Baguio City.
