

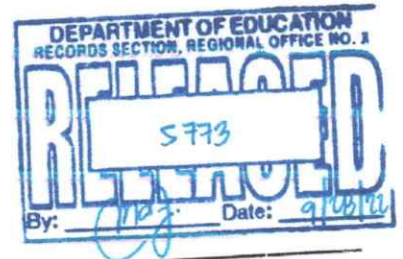

WEEKLY CONDUCT OF ONLINE REGIONAL MEETINGS


1. By virtue of Republic Act (RA) 9155, the Department of Education (DepEd) shall adhere to the principle of shared governance where every unit in the education bureaucracy has a particular role, task and responsibility inherent in the office and for which it is principally accountable for outcomes.
2. With reference to Section 2 of RA 9155, it is at the field offices — regions, divisions, schools and learning centers — where policies are translated into programs, projects and services developed, adapted and offered to address local needs.
3. In furtherance of the Department's efforts to empower the field officials vested with authority, accountability and responsibility within their respective levels, the Regional Directors (RDs) together with the Assistant Regional Directors are hereby instructed to call for online weekly meetings with Schools Division Superintendents (SDS) and Assistant Schools Division Superintendents (ASDS).
4. These shall serve as avenues for the field officials to discuss policies and actions that will address issues, concerns, and problems within their purview, consistent with the national educational policies, plans and standards.
5. In addition to the above, RDs must submit a monthly report of the issues, concerns, and problems reported to them by the SDS and the ASDS, as well as a status report of resolved items from the said meetings.
6. Immediate dissemination of and strict compliance with this Memorandum is required.
