- 1. Pursuant to DepEd Order No. 014, s. 2018 Re: Policy Guidelines on the Administration of the Revised Philippine Informal Reading Inventory, this Office shall conduct a Reorientation on DepEd Order No. 014, s. 2018 and Philippine Informal Reading Inventory (Phil-IRI) Manual 2018 used as a classroom-based assessment which aims to measure and describe the learner's performance in both English and Filipino languages on October 14, 2022, 1:00 p.m. 4:30 p.m. at Cogon National High School, Cogon, El Salvador City.
- 2. The activity aims to:
 - A. revisit and familiarize the policy guidelines on the administration of the revised Philippine Informal Reading Inventory (Phil-IRI);
 - B. update teachers on Phil-IRI Manual 2018; and
 - C. provide a venue for teachers to clarify their roles in planning, redesigning the reading instruction and school's reading programs or activities to improve reading performance.
- 3. The participants to this reorientation are the division reading coordinators, school heads and school's reading coordinators for English and Filipino subjects. Each coordinator is advised to print the soft copy of the Phil-IRI Manual 2018 and bring the same during the orientation. In addition, school heads are advised to bring their respective school reading program for SY 2022-2023.
- 4. The participants shall strictly observe the health protocols such as physical distancing and the wearing of face masks at all times.
- 5. This Office shall adhere to Equal Opportunity Principle (EOP) in receiving the General Plan of Activities and Attending to clarification/queries relative to the Reorientation on DepEd Order No. 14, s. 2018 and The Philippine Informal Reading Inventory Manual 2018.
