JUNIOR CHEMISTRY CONGRESS



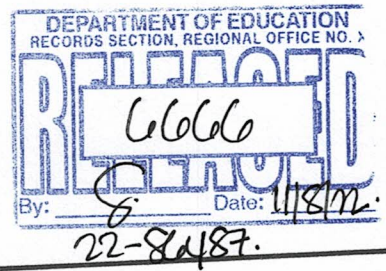

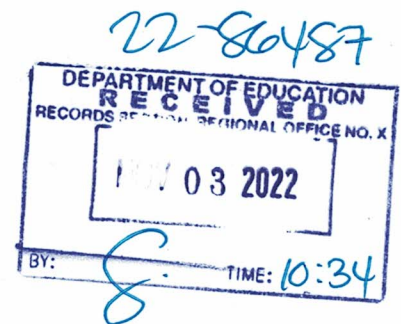
