Pursuant to DepEd Order No. 55, s. 2016 on the Policy Guidelines on the National Assessment on Learning for the K-12 Basic Education Program and in line with the implementation of the Project Standardized electronic Assessment (Project SeA), this Office requires all schools to conduct the Division Quarterly Assessment for the First Quarter on **November 7-8, 2022**.

2. The assessment aims to determine the learners' performance gaps and identify the appropriate interventions to improve learning.

3. All learners from Grade 1 to 12 are required to take the five (5) item-test of each learning area. The result of the assessment shall be submitted to the division office through the Curriculum Implementation Division on or before November 11, 2022.
