1. In connection with the attached Regional Memorandum No. 695, s. 2022, this Office reiterates the **Maintenance of Transparency Board in the Schools and in the Division Office.**
2. This issuance conforms with the provisions of Republic Act No. 9485 or the Anti-Red Tape Act of 2007 (An Act to improve Efficiency in the Delivery of Government Service to the Public by Reducing Bureaucratic Red Tape, Preventing Graft and Corruption, and Providing Penalties Thereof), and DepEd Order No. 13, s. 2016 on the Implementing Guidelines on the Direct Release and use of Maintenance and Other Operating Expenses (MOOE) Allocations of Schools, including Other Funds Managed by Schools under Section VI provision 27.4 on Reporting Requirements.
3. Hence, this Office directs all schools to post information on the sources, intended use, and actual utilization of school funds in their Transparency Boards that must be accessible and updated every three months.
4. All are reminded that this Office adheres to Equal Opportunity Principle (EOP). Hence, all decisions and actions are based solely on guidelines set forth, with no discrimination on the account of age, gender identity, sexual orientation, civil status, disability, religion, ethnicity or political affiliation.

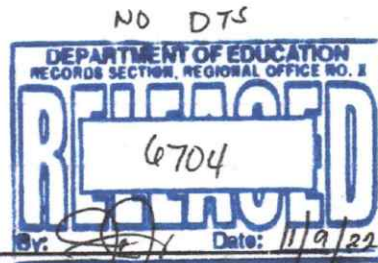
