- 5. The teacher-participants shall be entitled to service credits in accordance with DepEd Order No. 52, s. 2003 titled Updated Guidelines on the Grant of Vacation Service Credits for Teachers. However, non-teaching personnel shall be given Compensatory Time-Off (CTO) per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered, specific attention on Section 5.
