**SIMULTANEOUS CONDUCT OF QUICK READING ASSESSMENT  
FOR SELECT GRADE 6 LEARNERS SY 2022-2023**

1. Pursuant to **DepEd Memorandum No. 173, s. 2019 known as HAMON: Bawat Bata Bumabasa (3Bs Initiative)**, **Regional Memorandum No. 243, s. 2019 re Implementation of Project Care for NorMin Readers (CNR)** and in support to inclusive education, this Office will conduct a **Simultaneous Quick Reading Assessment (QRA)** to select Grade 6 learners in all elementary schools to understand the context of reading performance of the division and thereby strengthen the reading programs, projects and activities in all schools to improve the reading proficiency level of every learner in El Salvador City. The said QRA shall be facilitated by the Technical Assistance Providers (TAPs) on June 1-2, 2023 at various elementary schools in the division.
2. The activity aims to:
  - a. improve reading programs, projects and activities that would help learners develop and increase reading performance;
  - b. strengthen partnerships among stakeholders for the improvement of reading activities and learners reading performance in the Division and El Salvador City; and
  - c. nurture a culture of reading at homes, in schools, and communities.
3. The participants are encouraged to observe health protocols at all times.
4. This Office shall adhere to Equal Opportunity Principle (EOP) in receiving the General Plan of Activities and Attending to clarification/queries relative to the Simultaneous Conduct of Quick Reading Assessment for Select Grade 6 Learners SY 2022-2023. Hence, all decisions and actions shall be based on guidelines set forth, with no discrimination on the account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity or political affiliation.


