- 1. Relative to DepEd Order No. 27, s. 2022, re Conduct of Comprehensive Rapid Assessment for School Year 2021-2022 for Learning Recovery, as well as in Preparation for 2024 Baseline System Assessment, this division will adopt the Comprehensive Rapid Literacy Assessment (CRLA) as a system to detect the learning gaps of Grades 1 3 learners and establish a new system of assessment.
- 2. In connection with the Comprehensive Rapid Literacy Assessment (CRLA), the Division of El Salvador City will conduct a virtual orientation on June 26, 2023, from 1:00pm to 5:00pm via Google Meet. The link will be posted in the morning on the same day.
