- 3. The participants' meal, travel and other incidental expenses shall be charged against Program Support Fund for the implementation of National Learning Camp subject to the usual accounting and auditing rules and procedures.
- 4. The participants shall be entitled to service credits in accordance with DepEd Order No, 52 s. 2003 entitled *Updated Guidelines on Grant of Vacation service Credits to Teachers*. However, non-teaching personnel shall be given *Compensatory Time-Off (CTO)* per Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2 s. 2004 on *Non Monetary Remuneration for Overtime Service Rendered*, specific attention on Section 5.
- 5. This Office shall adhere to Equal Opportunity Principle (EOP) in the steps undertaken for this purpose. Hence, all decisions and actions shall be based on guidelines set forth, with no discrimination on the account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity, or political affiliation.
- All participants shall observe the minimum public health standards and safety protocol in all activities to be undertaken during this training.
