### INVITATION TO BID FOR

*Supply and Delivery of Enhanced Nutribun & Fortified/ Enriched Bread (PN. 2023-07-0001), Nutri-Oats & Nutripack (PN. 2023-07-0002), and Iron Fortified Rice (PN. 2023-07-0003) for the Conduct of School-based feeding program for SY 2023-2024 in the Division of El Salvador City*

1. The **Department of Education, Division of El Salvador City**, through the *General Appropriations Act of CY 2023* intends to apply the sum of *Six Hundred Forty-Two Thousand Four Hundred Ninety-Two Pesos Only (Php. 642,492.00)* for Lot 1, *Four Hundred Ninety-Nine Thousand Seven Hundred Sixteen Pesos Only (Php. 499,716.00)* for Lot 2 and *Two Hundred Eighty-Five Thousand Five Hundred Fifty-Two Pesos Only (Php. 285,552.00)* for Lot 3 being the ABC to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

Bidders should have completed, within **One Year** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
