CONTRACT AGREEMENT

Contract No. 2023-09-0001

THIS AGREEMENT made the <u>1st</u> day of <u>September</u> <u>2023</u> between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called "the Entity") of the one part and **THE LIFE-GIVING PRODUCTS AND SPECIALTY (MANHU – THE LIFEGIVINGBREAD) CORP.**, represented herein by its owner **GILBERT ABELLA GABUTAN**, with office address at Tlgpsc Bldg., South Diversion Road, Indahag, Cagayan de Oro City by (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Procurement of Supply and Delivery of Enhanced Nutribun and Fortified/ Enriched Bread (PN. 2023-07-0001) for the Conduct of School-Based Feeding Program for SY 2023-2024 - in the Division of El Salvador City-Lot 1 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Six Hundred Thirty-Three Thousand Five Hundred Sixty-Eight Pesos and Fifty Centavos (Php. 633,568.50) (hereinafter called "the Contract Price").
