CONTRACT AGREEMENT
 Contract No. 2023-09-0001

THIS AGREEMENT made the **1st** day of **September 2023** between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called “the Entity”) of the one part and **THE LIFE-GIVING PRODUCTS AND SPECIALTY (MANHU – THE LIFEGIVINGBREAD) CORP.**, represented herein by its owner **GILBERT ABELLA GABUTAN**, with office address at Tlgpsc Bldg., South Diversion Road, Indahag, Cagayan de Oro City by (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Supply and Delivery of Enhanced Nutribun and Fortified/ Enriched Bread (PN. 2023-07-0001) for the Conduct of School-Based Feeding Program for SY 2023-2024 - in the Division of El Salvador City- Lot 1** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Six Hundred Thirty-Three Thousand Five Hundred Sixty-Eight Pesos and Fifty Centavos (Php. 633,568.50)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

 - iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Six Hundred Thirty-Three Thousand Five Hundred Sixty-Eight Pesos and Fifty Centavos (Php. 633,568.50)** or such other sums as may be ascertained, **THE LIFE-GIVING PRODUCTS AND SPECIALTY (MANHU - THE LIFEGIVINGBREAD) CORP.** agrees to supply and deliver for the **Procurement of Enhanced Nutribun and Fortified/ Enriched Bread (PN. 2023-07-0001) for the Conduct of School-Based Feeding Program for SY 2023-2024 - in the Division of El Salvador City- Lot 1** in accordance with his Bid.
4. The **Department of Education, Division of El Salvador City** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The works referred to this Contract shall be executed within the contract duration of 54 days, which shall commence on 18 SEP 2023 (date) and not earlier than the date of
