CONTRACT AGREEMENT
Contract No. 2023-09-0002

THIS AGREEMENT made the **1st** day of **September 2023** between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called “the Entity”) of the one part and **ASAHI RESOURCES CORPORATION**, represented herein by **ALEJANDRO B. CUYOS**, with office address at No. 8, St. Dominic St., ITC Compound, Bagbaguin, Valenzuela City, Metro Manila (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of Nutri-Oats and Nutri-Pack (PN. 2023-07-0002) for the Conduct of School-Based Feeding Program for SY 2023-2024 in the Division of El Salvador City (Lot 2)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Four Hundred Eighty-Five Thousand Eight Hundred Thirty-Five Pesos (Php. 485,835.00)** (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised **Implementing Rules and Regulations** of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto;
