### CONTRACT AGREEMENT

Contract No. 2023-09-0003

THIS AGREEMENT made the <u>1st</u> day of <u>September 2023</u> between **Department of Education**, **Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called "the Entity") of the one part and **ASAHI RESOURCES CORPORATION**, represented herein by **ALEJANDRO B. CUYOS**, with office address at No. 8, St. Dominic St., ITC Compound, Bagbaguin, Valenzuela City, Metro Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly Supply and Delivery of Iron Fortified Rice (PN. 2023-07-0003) for the Conduct of School-Based Feeding Program for SY 2023-2024 in the Division of El Salvador City (Lot 3) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Hundred Sixty Thousand Nine Hundred Sixty-Two Pesos and Eighty Centavos Only (Php260,962.80) (hereinafter called "the Contract Price").

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto;
