ORIENTATION ON DEPED ORDER NO. 13, S. 2022 (OMNIBUS GUIDELINES ON THE REGULATION OF OPERATIONS OF PARENT-TEACHER ASSOCIATIONS)

1. The active and collaborative engagements among parents, teachers, the school, and the community are critical for ensuring the welfare of the learners. As amended, the state recognizes this invaluable partnership through Presidential Decree (PD) 603 (Child and Youth Welfare Code). Specifically, Article 77 of PD 603 called for a Parent-Teacher Association (PTA) formation in every school community.
2. Hence, this Office, through the Schools Governance and Operations Division (SGOD), will conduct a Division Orientation on DepEd Order No. 13, s. 2023, titled Omnibus Guidelines on the Regulation of Operations of Parent-Teacher Associations at McDonald's, PSB, El Salvador City, on October 20, 2023, from 8:00 AM -5:00 PM.

 - a. promote harmonious, active, and collaborative engagement among teachers, parents, and the community in the implementation of school programs for learners' welfare;
