correct spelling for at least two words after identifying the champion. The third place shall be given to the third member of the finalists after the champion and the second placer have been determined, respectively.

- 2. A dry-run shall be conducted on November 7, 2023 at 10:00a.m. at El Salvador City Central, El Salvador City. This shall be participated in by the members of the BEE Officials. The coaches are encouraged to join said dry-run through virtual participation. Link shall be provided in the group chat.
- 3. All other provisions in the abovementioned memorandum shall remain in effect.
- 4.
