- d. Provide close horizontal and vertical coordination and consultation among DepEd, COMELEC, partner agencies involved in the 2023 BSKE; and
- e. Complement the other government agencies' efforts for an honest, orderly, and peaceful elections.
- 4. Meals and snacks of the BSK-DETF shall be charged to the Division MOOE/local funds subject to the usual auditing rules and regulations. Moreover, as stipulated in the DepEd Memorandum No. 063, s. 2023, the grant of honoraria to officials and personnel who will render services to their respective ETFs shall be subject to existing Commission on Audit rules and regulations, as well as issuances from the Department of Budget and Management relative to the matter.
- 5. Payments of overtime or the grant of compensatory time-off to qualified personnel are authorized, subject to the availability of funds and existing auditing rules and regulations, including applicable Civil Service laws.
- 6. This office adheres to the Equal Opportunity Principle (EOP) in observing all policies and protocols. Hence all action shall be based solely on guidelines set with no discrimination on age, gender identity, sexual orientation, civil status, disability, religion, ethnicity, or political affiliation.
- 7. Immediate and wide dissemination of this Memorandum is directed.
