#### CONTRACT AGREEMENT

## Contract No. 2023-12-0006

THIS AGREEMENT made the 11th day of December 2023 between Department of Education, Division of El Salvador City, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, RANDOLPH B. TORTOLA, (hereinafter called "the Entity") of the one part and BUENA PEARL PRINTSHOP, represented herein by its Project Supervisor, MARILYN E. BALOG, with office address at Yacapin-Rizal Sts., Cagayan de Oro City by (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **Procurement of Printing and Delivery of Bridging Primer II**Learning Resources for FY 2023 in the Department of Education, Division of El Salvador City (PN 2023-11-0007) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Hundred Ninety-One Thousand Six Hundred Twenty Pesos Only (Php. 191,620.00) (hereinafter called "the Contract Price").
