A complete set of Bidding Documents may be acquired by interested bidders on *December 3,2023* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (<u>Php.5,000.00</u>). The Procuring Entity shall allow the bidder to present its proof of payment for the fees *presented in person*,
- 6. The Department of Education, Division of El Salvador City will hold a Pre-Bid Conference<sup>1</sup> on December 11, 2023, 9:00 O'clock in the morning at Department of Education, Division Office, Conference Room, Jade Building, and/or Zone 3. Tuburan. Poblacion, El Salvador City through videoconferencing/webcasting google via meet (Link: meet.google.com/kws-xkkc-eia), which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through *manual submission* at the office address as indicated below, on or before *December 26, 2023, 8:50 AM in the morning.* Late bids shall not be accepted.

The *Department of Education, Division of El Salvador City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
