
1. This is to remind all employees on the submission of the following documents and their corresponding deadlines:

Document	Deadline
Statement of Assets, Liabilities and Net Worth (SALN) as of December 31, 2023	February 29, 2024
updated CS Form No. 212 (Revised 2017), otherwise known as Personal Data Sheet (PDS)	March 29, 2024

- 2. All employees are reminded that the submission of a SALN is required by law under Article XI Section 17 of the 1987 Constitution and Section 8 of republic Act No. 6713, the "Code of Conduct and Ethical Standards for Public Officials and Employees." Failure to file the SALN warrants the suspension of one to six months for the first offense, and dismissal from the service for the second offense.
- 3. Further, all are informed that the Civil Service Commission (CSC) requires the submission of as separate **Work Experience Sheet**, where employees shall indicate their actual duties for each position declared in the PDS under the Work Experience field. These shall be used by the Commission in evaluating appointments issued, particularly in checking whether the appointee's qualifications meet the requirements of the vacant position being filled.
- 4. Soft copy of the SALN and PDS forms, including the guide in filling out the form, may be downloaded from the Division Website (https://depedelsalvadorcity.net/) under Downloadable Forms. This is to ensure that the form used across the Division is uniform and correctly filled
