The **Department of Education, Division of El Salvador City**, through the **General Appropriations Act of CY 2024** intends to apply the sum of **Two Million Nine Hundred Ninety-Four Thousand Three Hundred Sixty One Pesos (Php. 2,994,361.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for *the Procurement of Construction of Health Facilities at San Francisco De Asis Elementary School with PN-2024-01-0002*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

A complete set of Bidding Documents may be acquired by interested bidders on *January 16, 2024* from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (Php.5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *presented in person*,
