OBSERVANCE OF THE 2024 NATIONAL ARTS MONTH CELEBRATION

1. In reference to attached Regional Memorandum No. 043 s. 2024, *2024 National Arts Month Celebration*, this Office hereby informs the field of the observance of the 2024 national arts month celebration on February 2024.

The activity aims to (a) promote cultural appreciation of various arts forms such as visual arts, dance, music, literature and theater, (b) support and recognize the contributions of local artist in the region, (c) and foster creativity and expression through exhibitions, performances, and other artistic activities.
3. Schools are advised to conduct a kickoff activity on February 5, Monday, during the flag-raising ceremony to inform the school community about the importance of understanding and appreciating the arts, which are an integral component of a well-rounded and culturally rich society.
4. School heads and MAPEH teachers are expected to conduct initiative activities relative to the observance of **NAM 2024**.
5. School heads are expected to report their consolidated activity completion reports to this link <https://shorturl.at/qwHU7>.
6. During the **NAM 2024** celebration, there must be no disruption of contact time between the teachers and learners, as stipulated in the DepEd Order No. 95, s. 2005, Instituting Measures to Increase Engaged Time-on-Task and Ensuring compliance therewith.
7. This Office shall adhere to Equal Opportunity Principle (EOP) in the steps undertaken for this purpose. Hence, all decisions and actions shall be based on guidelines set forth, with no discrimination on the account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity or political affiliation.



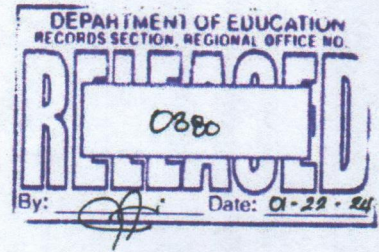


