DESIGNATED DROP-OFF POINTS OF SUPPLIES

To: All Elementary and Secondary School Heads **Project Development Officers I Administrative Officers II** All others concerned This Division

- 1. In line with the recent issuance of DepED Order No. 002, s. 2024, titled Immediate Removal of Administrative Tasks of Public School Teachers, and the deployment of the non-teaching personnel to their respective school assignments, it has been observed that there is a need for clarification regarding the logistics of supply delivery to clustered schools within our division.
- 2. To address this concern, the division has designated drop-off points for the delivery of supplies and shall observe the requirements of RA 9184, otherwise known as the Government Procurement Reform Act and its Implementing Rules and Regulations (IRR), allowing the personnel handling clustered schools to choose locations that best facilitate the distribution process. These drop-off points aim to streamline the logistics of supply delivery, ensuring that all schools under the purview of the assigned personnel receive the necessary resources promptly.
- 3. Below is the list of personnel and their selected drop-off points that shall take effect on April 1, 2024:
