TO PROFESSIONAL REGULATION COMMISSION'S CONTINUING PROFESSIONAL
DEVELOPMENT ACCREDITATION SYSTEM (CPDAS)
AND APPLICATION FOR CPDAS ACCREDITATION

- 1. Following Republic Act No. 10912 known as the Continuing Professional Development (CPD) Act of 2016, this Office, through the Human Resource Development Division National Educators' Academy of the Philippines in the Region (NEAP R), requires all the PRC-licensed professionals under DepEd Region X Northern Mindanao to register to the Continuing Professional Development Accreditation System (CPDAS) under Professional Account until April 1, 2024.
- 2. All teachers, school leaders, teaching-related, and nonteaching personnel under DepEd Region X Northern Mindanao who are PRC-licensed professionals are expected to register to ensure that all personnel have access to monitor their CPD units acquired during the participation in/attendance at accredited trainings, seminars, or activities, and apply for **Self-Directed Learning** for activities attended, participated, and/or initiated in their school community.

Please ensure that all the information provided matches the information in your Professional Identification Card (PIC).
