CONTRACT AGREEMENT
 Contract No. 2024-04-0003

THIS AGREEMENT made the 3rd day of April 2024 between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called “the Entity”) of the one part and **DATAWORLD COMPUTER CENTER**, represented herein by **ROSELYN P. ROLLON**, with office address at No. 49 Don Tirso Neri St., Cagayan de Oro City (hereinafter called “the Supplier”) of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply, Delivery, Installation and Testing of ICT Equipment in the Division of El Salvador City Under the FY 2023 DepEd Computerization Program (DCP)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Four Hundred Eighty-Eight Thousand Eight Hundred Pesos** only (Php. 1,488,800.00) (hereinafter called “the Contract Price”).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
