


CHANGES TO DIVISION MEMORANDUM NO. 172, S. 2024 RE PARTICIPATION TO THE 2024 REGIONAL SCHOOLS PRESS CONFERENCE (RSPC)

- 1. In reference to Regional Memorandum No. 0286, s. 2024 re Addendum and Corrigendum to Regional Memorandum to the 2024 Regional Schools Press Conference (RSPC) and Division Memorandum No. 172, s. 2024 re Participation to the 2024 Regional Schools Press Conference, the field is hereby informed of the following changes:
 - A. The participants' meals, travel, and other expenses shall be charged to SEF/local funds and other fund sources, subject to the usual accounting and auditing policies, rules, and regulations;
 - B. A membership fee of Thirty Pesos (P30.00) for campus journalists and Sixty Pesos (P60.00) for school paper advisers will be charged for each participant to defray the expenses for the tokens of the outstanding campus journalists. These fees, along with the membership fee for the RSPC and NSPC organizations, shall be chargeable against the school MOOE/local/SEF/School Campus Journalism Fund or any other available funds, subject to the usual accounting and auditing rules and regulations;
 - C. Participants to the 2024 RSPC shall include Sherrie R. Dungog, Division ITO, as TWG and member of the Working Committee;
 - D. The billeting of the delegation of El Salvador City shall be changed from North City Central School, Puntod, Cagayan de Or City to Molugan Central School, Molugan, El Salvador City; and
 - E. Except Molugan Central School, all public elementary and secondary schools are requested to bring four (4) beddings per school, to be delivered at Molugan Central School on or before May 1, 2024. All school heads are advised to coordinate with the School Head or Working Committee of Molugan Central School for an orderly distribution and retrieval of beddings.
- 3. The participants are reminded to bring the needed paraphernalia for their respective contest events, toiletries and other personal necessities.

Further, teacher's participation shall be subject to the no-disruption of classes policy stipulated in DepEd Order No. 9, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance therewith, Republic Act No. 5546 (Section 3 Policy on Contributions), and DepEd Order No. 66, s. 2017 (Policy on Off-Campus Activities) and School Heads must ensure that their classes will be handled by another teacher.
- 5. The teacher participants involved in the conduct of the activities done during the weekend and/or holidays shall be entitled to service credits in accordance with DepEd Order No. 52, s. 2003 entitled Updated Guidelines on Grant of Vacation Service Credits to Teachers. On the other hand, non-teaching staff shall be provided with Compensatory Time-Off (CTO) per Civil Service Commission and Department of Budget and Management Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
- 6. This Office shall adhere to Equal Opportunity Principle (EOP) in receiving the General Plan of Activities and Attending to clarification/queries relative to the 2024 Regional Schools Press Conference. Hence, all decisions and actions shall be based on guidelines set forth, with no discrimination on the account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity or political affiliation.
- 7. Immediate and wide dissemination of this memorandum is desired.
