WHEREAS, in response to the said advertisement/s, one (1) bidder submitted bid during the opening;

WHEREAS, during the opening of bids on February 7, 2024, one (1) bidder passed in the preliminary evaluation of bids with **CCO ENGINEERING CONSTRUCTION AND SUPPLY**, as the lowest calculated bid as read below;
