RESOLUTION TO AWARD

WHEREAS, the Department of Education, Division of El Salvador City advertised the Invitation to Apply for Eligibility and to Bid for the *Procurement of Construction of School Building (with Toilet) with Provision of Rainwater Collector, School Furniture, Solar PV Energy System, Water System and Flood Marker at Sambulawan National High School with PN-2024-01-0003 and posted the same in the PhilGEPS;*

WHEREAS, in response to the said advertisement/s, four (4) bidders submitted bid during the opening;

WHEREAS, during the opening of bids on February 7, 2024, four (4) bidders passed in the preliminary evaluation of bids with *JDE CONSTRUCTION*, as the lowest calculated bid as read below;
