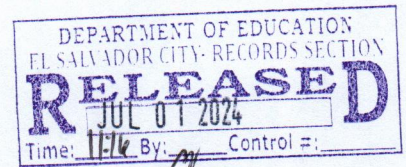

REMOVAL OF ROAD BARRICADE NEAR SCHOOL ZONES ON SPECIFIED HOURS DURING SCHOOL DAYS

To: **Assistant Schools Division Superintendent**
All Public Elementary and Secondary School Heads
All Others Concerned
This Division

1. Pursuant to Regional Memorandum 457, s.2024 entitled **Removal of Road Barricade Near School Zones on Specified Hours During School Days**, this Office hereby informs the field to follow the recommended schedule on the installation of road barricade.
2. Road barricade ensure safety measures for learners coming in and out of the school. Hence, the removal of barricade avoids inconvenience and distraction to the riding public who would traverse using the same roads.
3. Further, School Heads shall coordinate with the barangay to ensure that the road barricade must be at 40-60 meters in distance and must installed and set-up only during school days with the following schedule:

Schedule	Time
Morning	6:30 AM to 7:30 AM
Noon	11:30 AM to 1:00 PM
Afternoon	4:00 PM to 5:00 PM

4. Moreover, all form of road blockage shall be removed beyond the recommended time. School Heads shall request the barangay to assign personnel who will render assistance to students going inside and outside the school's premises especially during hours outside these schedules.
5. This Office adheres to the Equal Opportunity Principle (EOP) in observing all policies and protocol. Hence, all actions shall be based solely on guidelines set with no discrimination on the account of age, gender

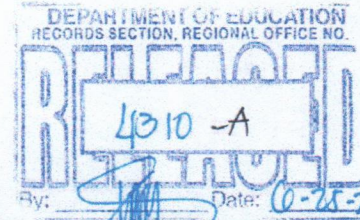



**REMOVAL OF ROAD BARRICADE NEAR SCHOOL ZONES
ON SPECIFIED HOURS DURING SCHOOL DAYS.**

To: Schools Division Superintendents
All Others Concerned

1. There are existing barricades established in the roads near the school zones as safety measures for the learners coming in and out of the school using these roads.
2. As such, these barricades have caused inconvenience and distraction to the riding public who would traverse using the same roads.
3. To remedy the situation and considering the needs of all the parties concerned, the school heads shall coordinate with the barangay to ensure that the road barricades must be at 40 to 60 meters each in distance and must be installed and set up only during school days with the following schedule:
 - a. 6:30 in the morning until 7:30 in the morning
 - b. 11:30 in the morning until 1:00 in the afternoon and
 - c. 4:00 in the afternoon until 5:00 in the afternoon
4. The hours in between, all forms of road blockages shall be removed therefrom, and the school heads shall request the barangay to assign personnel who will render assistance to students going inside and outside the school's premises especially during hours outside these schedules.
5. This Office directs the immediate and wide dissemination of this Memorandum.
