### ELECTION OF SCHOOL PARENT-TEACHER-ASSOCIATION (SPTA) FOR SY 2024-2025

To: **Assistant Schools Division Superintendent Chief Education Supervisors Education Program Supervisor, SGOD Public Elementary and Secondary School Heads** All Others Concerned This Division

- 1. Pursuant to DepEd Order No. 13, s. 2022 titled Omnibus Guidelines on the Regulation of Operation of Parents-Teachers Associations, this Office, through the School Governance and Operations Division, directs the field to conduct School Parent-Teachers Association (SPTA) election of officers for SY 2024-2025.
- 2. The conduct of elections of the new set of officers for SPTA-BOD shall be held within thirty (30) days from the first day of classes consistent with Section 12.1 hereof.
- 3. A General Assembly shall be convened by the school head and incumbent (outgoing) BOD prior to the election. Such GA may be held on the same date or before the actual date of election.
- 4. Consistent with the last paragraph of Section 5.1 hereof, guardians of learners who are legally appointed as such by a competent court may hold a position in the Homeroom, Grade Level, School PTAs, and/or Federated PTAs.
- 5. The total number of SPTA-BOD members in every school is found in the attachment.
- 6. This office adheres to the Equal Opportunity Principle (EOP). Hence, all actions shall be based solely on the guidelines set with no discrimination on account of age, gender, identity, sexual orientation, civil status, disability, religion, ethnicity, or political affiliation.
