**CONTRACT AGREEMENT**  
**Contract No. 2024-08-0006**

THIS AGREEMENT made the **9th** day of **August 2024** between **Department of Education, Division of El Salvador City**, located at Zone 3, Tuburan, Poblacion, El Salvador City of the Philippines, represented herein by its Schools Division Superintendent, **RANDOLPH B. TORTOLA**, (hereinafter called "the Entity") of the one part and **THE LIFE-GIVING PRODUCTS AND SPECIALTY (MANHU - THE LIFE GIVING BREAD) CORP.**, represented herein by **GILBERT A. GABUTAN**, with office address at Indahag, Cagayan de Oro City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Lot 2- Supply and Delivery of Fortified/Enriched Bread + Juice (Calamansi with Honey), for the Conduct of School-Based Feeding Program for SY 2024-2025 in the Division of El Salvador City (PN:2024-06-0018)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Hundred Fifty-Eight Thousand Nine Hundred Ninety-Two Pesos Only (Php 358, 992.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
